**Terms of Service Agreement**

For the sum of the services listed above, an instructor licensed by the State of New Jersey will provide the services. The vehicle used for the instruction will be equipped with dual brakes, registered, and insured as required by the NJMVC. For Students who are 16 years of age, Cornely Driving School will purchase the student permit prior to behind the wheel training. For Students 17 or older, a valid NJ permit of license must be obtained prior to any behind the wheel training. All training will be conducted during the hours of 6am and 9pm, at a time agreed upon by the Student and the School. Lessons will be completed in 2 hour blocks (120 minutes), or 3 hour blocks (180 minutes). No lesson will exceed 3 hours in one 24 hour period. The time designated for the lesson shall be the actual amount of time provided by the School. The Vehicle used for instruction will be automatic transmission.

The Parent/Guardian, Adult Student or School may cancel this contract up to seventy-two (72) hours prior to the date of the scheduled service. Forty-eight (48) hours advanced notice is required to cancel or reschedule a lesson. Cancellation must be made through the School phone number 856-429-7233.

The only occupants of the driving school vehicle, on public roads or highways, for the purpose of the required 6 hours of behind the wheel training, will be the student, the instructor, and instructors in training.

No additional fees will be charged other than those specified above. I also give my consent to receiving text notifications for additional services and permit pickup instructions.

This constitutes the entire agreement between the School and the student, or the School and The Parent/Legal Guardian if the Student is under 18 and no verbal statements or promises will be recognized.

We have read this Service Agreement and agree to the provisions.
